# Investment Giving:

## Qualified Charitable Distributions from IRA

If you are at least 70½ years old, you may make a qualified charitable distribution from your individual retirement account (IRA) without paying additional taxes. For those age 73 and above, a qualified charitable distribution to Global Refuge fulfills your annual required minimum distribution (RMD). Contact your financial advisor to make a gift to Global Refuge (EIN 13-2574854).

## Donor-Advised Fund

A donor-advised fund is one of the easiest and most tax-advantageous ways to give to charity. As you make annual disbursements from your donor-advised fund, consider Global Refuge (EIN 13-2574854) in your giving plan.

## Gifts of Stock or Securities

Leverage exceptional tax benefits and a streamlined donation with a gift of stock or securities to Global Refuge. Please visit 'more ways to give' using the QR code on the front to access brokerage and account information for the transfer.

## Cryptocurrency

You may donate cryptocurrency or stocks directly from your crypto wallet or stock portfolio. Donating crypto is safe, easy, and fast. Making a charitable gift is a quick three-step process:

- 1 Select your preferred crypto and enter your gift amount;
- 2 Type in your email and basic info (or choose to give anonymously); and
- 3 Make your gift!

Upon making a donation, you can elect to receive an automatically generated tax receipt that will be sent to the email address you provide.
